- Enter your Webfile number from this letter and select "Continue."
- Complete the Franchise Questionnaire.

If the questionnaire is not received, the entity will be liable for franchise tax beginning on the date that it registered to transact business in Texas. If we later determine that the entity had activity in Texas prior to the registration date, additional tax may be due.

Please note that beginning with reports due in 2024, if your annualized total revenue is under the no tax due threshold, you do not have to file a franchise tax report but must still file a Public Information Report or Ownership Information Report.
